- 2. The appointees shall submit their joining reports physically to the concerned District Ayush Officers/District Nodal Officers Ayush/DDOs of the Department and in case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-inito without any further notice.
- 3. The appointees shall be allowed to join by the concerned District Ayush Officers/District Nodal Officers Ayush/DDOs only on production of the following certificates in original:
 - j. Academic qualification certificates.
 - ii. Matriculation/Date of Birth certificate.
 - iii. Health Certificate issued by the Standing Medical Board of the District.
 - iv. Domicile Certificate issued by the Competent Authority.
 - v. Certificates from the District Industries Centre (DIC) and District Employment & Counseling to the effect that no loan under the self employment scheme has been taken by the appointee.
 - vi. Relevant category certificate (s), (in case of candidates belonging to reserved categories).
 - vii. Any other certificates /documents as required under rules/norms.
- 4. The Provisions for probation pay & allowances and fixed tenure of five years/seven years on initial engagement of the appointees shall be governed in terms of the J&K Probationer (Condition of Service, pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 dated. 17.06.2020.
- 5. The appointees shall give an undertaking duly attested by the First Class Judicial Magistrate with the effect that:-
- i) If on verification from the concerned issuing authorities, the qualification certificate/reserved category certificate/experience certificate (wherever applicable) is found forged, false or fake, the appointee shall have no claim for appointment.
- Salary of the appointees shall not be drawn and disbursed to him/her unless and until the satisfactory report/genuineness of the certificates in respect of conditions 5(i) is received.
