
Terms & Conditions:

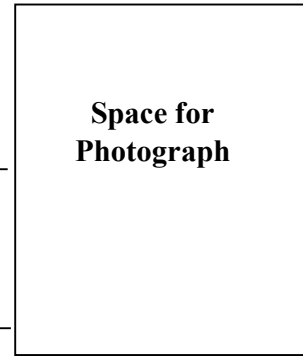
6. The number of vacancies are only indicative and may increase or decrease.
