

2. The candidate(s) who fail to join within a period of 21 (twenty-one) days from the date of issuance of this notice shall forfeit their right to engagement which shall be deemed to have been cancelled *ab-initio* without any further notice and the waiting list shall be operated accordingly.
3. The selected candidate(s), if working in any other organization, shall have to submit NOC from the competent authority of that Organization.
4. The contract shall be valid initially upto 31.03.2021 and will be effective from the date of joining of the candidate(s).
5. The candidate(s) shall be allowed to join only after production of original testimonials to the concerned DDO, who shall also get these testimonials verified from the issuing authorities.
