Subject: Selection List of waitlisted candidates for hiring under National AYUSH Mission

- i. Whereas, the selection list of the candidates hired under National AYUSH Mission was issued vide No. DISM/NAM/12977-80 dated 19.03.2020 duly published in leading newspapers and also displayed on the official website of the Directorate; and
- ii. Whereas, as per the condition No. I of the terms and conditions of the selection list, 21 days was granted to the selected candidates for joining from the date of issuance of the notice, which is reproduced as under:
"The candidate(s) who fail to join within a period of 21 (twenty-one) days from the date of issuance of this notice shall forego their right to engagement which shall be deemed to have been cancelled ab-initio without any further notice and the waiting list shall be operated accordingly".
- iii. Whereas, 15 days extension in the joining time was granted to the selected candidates vide No. DISM/NAM/164 dated 08.04.2020, keeping in view the lockdown due to COVID-19 pandemic; and
- iv. Whereas, vide this Office letter No. DISM/NAM/579-85 dated 22.04.2020, information was sought from the concerned DDOs regarding the details of the candidates who joined at their places of postings as mentioned in the selection list quoted above; and
- v. Whereas, as per the information submitted by the concerned DDOs, following posts remained vacant due to non-joining of the candidates, who forfeited their right to engagement;

Terms & Conditions:

1. The selected candidates can collect their engagement letters from the Office of the Director ISM, Indira Chowk Jammu/Deputy Director ISM Office Kashmir, Shalteng Srinagar. The candidates shall have to join within 21 days from the issuance of this selection list.
2. The candidate(s) who fail to join within a period of 21 (twenty-one) days from the date of issuance of this notice, shall forfeit their right to engagement which shall be deemed to have been cancelled *ab-initio* without any further notice and the candidates in the next waiting list shall be operated accordingly.
3. The selected candidate(s), if working in any other organization, shall have to submit NOC from the competent authority of that Organization at the time of joining.
4. The contract shall be valid initially for a period of one year and will be effective from the date of joining of these candidates.
5. The candidate(s) shall be allowed to join only after production of original testimonials to the concerned DDO, who shall get these testimonials verified from the issuing authorities.
6. The candidate(s) shall also have to execute an undertaking on affidavit from 1st Class Magistrate (on prescribed format) as per the terms & conditions mentioned in the Undertaking and Engagement letter, which he/she will have to submit before the concerned DDO along with joining.
7. The services of the selected candidates shall also be governed by the terms & conditions mentioned in their engagement letters issued by the Director, ISM (NAM) and other service conditions/amendments made from time to time in the interest of the organization.
